3. Money / Capital (PQA)

FROM NOW ON, NO ONE CAN BECOME INSOLVENT ANYMORE.

All global money/capital flows—controlled and managed by this court via the HANSE INTERNATIONAL BANK (HIB)—into the existing collateral accounts of all people in equal shares, making them their property as so-called "Private Q-Collateral Accounts (PQA)" with sole access. The letter Q stands for quantum (smallest unit).

ACTION BY COUNTRY: It would mean—quite simply (!)—that all countries would grant the new PQA owners access to their existing collateral accounts (documented by their birth certificates), which would thereby become Private Q-Collateral Accounts (PQA). This is a process that is supported and protected by this court (IHG-DGR) and with the help of our bank (HIB).

ACTION by the people of all countries: This process has already been initiated for GERMANY and the UNITED STATES OF AMERICA (USA) by Hanseatics /Human Beings in Germany and our HANSE organization. The background to this is that the HANSE has twice (2 x) 350 trillion euros in its possession, which the HANSE wants to share with all Human Beings from GERMANY and the USA. These amounts were part of the court order of October 26, 2022, and were invoiced on November 7, 2022, with effect at the end of 2022 / 2023, one at UOB Singapore in Thailand (12/2022) and one to our bank HIB Europe (12/2023). The relevant facts are also documented in detail in our letter to all Human Beings of the USA, White House, USA, dated October 3, 2025.

Why should the second amount (350 trillion euros), which all Hanseatics in Germany have earned, be shared with the Hanseatics and all Human Beings in the USA? Reason: Without the USA and the associated global awakening processes, this PQA project would not have been possible in this time window (portal).


Step-3 | PQA owner receives a transfer to their PQA: \$1.0 million

The PQA's focus of the PQA is on every human being

"FROM NOW ONWARDS NO HUMAN BEING CAN EVER BECOME INSOLVENT"

All global money / capital goes—controlled and managed by this court—in equal parts to the existing collateral accounts of all Human Beings and becomes their own **Private Q-Collateral Account (PQA)** with single access. The letter Q stands for quantum (smallest unit).

A) HUMAN BEING

<u>The PQA serves everyone in all stages of life,</u> from birth and childhood, through education, school, and career preparation, to starting a career. Throughout one's professional career, it provides assistance in difficult situations (accidents, illness, medical treatment, job loss, career reorientation, etc.).

Additional note: Fear of AI (artificial intelligence) leading to job losses. Don't worry. Human Beings can start looking for work they have always wanted to do (their calling). The PQA is always there for "emergency situations/safe haven" and covers all costs until a new job is found that provides a regular income.

It is not intended, but every Human Being could basically live their entire life—at the level of basic needs—from their PQA. There is nothing negative about such a decision; freedom of choice.

It is an "emergency / safe haven" account that is 100% owned and controlled by the individual. The PQA account owner does not need to ask anyone for approval / permission to access the PQA.

The fundamental function of PQA is to bridge difficult situations throughout life, from the first breath to the last. It will compensate for all costs and expenses in full (100%), according to a person's current life situation with income and expenses, whenever an emergency situation arises.

All PQAs within a country are always linked to each other. This means that if you need more than what is credited to your account at the beginning of each year, e.g., the costs



for some special medical operations, you have access to a larger unlimited amount, which would be distributed proportionally across the total volume of all PQAs. This would remain the case until this account receives its new annual balance at 12:00 a.m. on December 31.

It is rebooked every year on 31DECYYYY at 00:00 by dividing the global money / capital by the number of all Human Beings on Earth and then allocating it to everyone's PQAs.

The PQA can be accessed via any computer-based device such as a smartphone, PC, or external ATM to scan the relevant invoice/handwritten note, leave an explanatory voice or video message, make transfers, and/or receive cash; emergency telephone numbers will also be available.

#Petition: The HANSE petition process is open to all Human Beings to address injustices that have been committed against themselves, their families, their businesses, and other assets and property, to document them, and to complete them in accordance with the HANSE standard. Losses in value and compensation can be claimed via the PQA.

#Insolvency: Insolvency is no longer possible, which also affects the past (retroactive validity). All insolvencies must be deleted from all legal documents, and the person affected has the right to receive compensation for financial losses by means of a #petition. For a description, see #petition.

When changing countries, the PQA can be transferred to the new country to become part of the National Trust PQA (NTP) there.

B) COUNTRY:

Countries and states do not own money or capital, nor does the state own any assets or property. All national assets and goods belong equally to all Human Beings of the same country, who together form the Nation.

NTP | All PQAs of such a nation together form the National Trust PQA (NTP); always 100% individually owned by all Human Beings of a Nation through their PQAs.

NFP | The National Fund PQA (NFP) is the annual budget/cash flow volume that is determined and approved by Parliament and ratified by the annual referendum of all PQA owners. It represents a quota of X% of the NTP, which is defined annually. The corresponding amount is transferred proportionally from all PQAs to the NFP account for use in the national budget. At the end of the year, the remaining amount in the NFP account is included in the calculation of the new annual budget by the responsible financial authority, which is submitted to Parliament as a draft to be voted on and approved by all PQA owners as a template for the referendum.

Note: No taxes or duties are levied beyond this NFP amount.
