1.1 DEEPSTATE (EU & THAILAND); 3rd PHASE

This court informs the worldwide DeepState today – represented by the European Union (#EU) – that on January 1, 2026, it is entering the 3rd phase of the witch hunt of the HANSE Organization and this court, due to the ongoing persecution in Thailand by the DeepState in Thailand through banks, lawyers, and other members of this international (Globalists / Bilderberg / WEF / Blackrock) network, influenced through its national and international members, forming a local criminal gang-like association in Thailand and incurred the following court penalty for witchhunting, analogous to Phase-1 with 8 billion and Phase-2 with 8 trillion, now as Phase-3 with:

USD 8,000,000,000,000,000.00 (In words: eight quadrillion)

Announcement:



These funds are intended for the PQA accounts of all Humans worldwide or for the country and for the PQAs of all its people, which is the first to start the PQA program, to be accounted up to the capping amount of EUR 30 million per PQA.
